# Course Description ~ 7th Grade Civics

**A. Major Concepts/Content:** The purpose of this course is to enable students to develop the knowledge and skills necessary for active participation in a democratic society. The information you will be responsible for learning has to do with the reasons, functions and the process of government. Specifically, the origins of the U.S. Govt are important to know and understand as well as the roles, rights, and responsibilities of a United States citizen. An important part of your experience this year involves active participation in our political system. Students will become informed citizens in regard to their local, state, & federal govt. Content includes, but not limited to:

-United States Constitution-contemporary social issues-role of individual in a democratic system-history and contemporary problems of Florida-rights, responsibilities, and obligations of citizens-problem-solving skills and strategies-development, structure, and functions of local, state, and national governments within constitutional and economic frameworks-foundations of the American political, social, and economic systems and institutions

- **1.** Demonstrate understanding of the legal, political, economic, and social system and traditions of the United States.
- 2. Demonstrate understanding of how major ideas/events have influenced the development of local, state, & federal governments.
- 3. Identify the structures/functions of local, state, & federal governments under the frameworks of the US & FL Constitutions
- 4. Demonstrate understanding of the duties, rights, and responsibilities of a citizen within our society.
- 5. Demonstrate understanding of the importance of participation in community service and political activities.
- 6. Demonstrate understanding of contemporary social issues that affect our political, economic, and social systems.
- 7. Evaluate the roles and contributions of women and diverse cultural groups in the political process.
- 8. Describe the impact of people, ideas & events on development of values, traditions, social-economic & political institutions in Florida.
- 9. Apply research, critical-thinking & decision-making skills & demonstrate the use of new & emerging technology in problem solving.
- E. Course Disclosure: \*Please Note\* Students will be assigned <u>pre-selected</u> topics based on cross-curricular content, current events/foreign affairs, and other relevant issues. Some topics may be sensitive and/or controversial in nature as they may account for historical significance and/or are relevant (i.e.; North Korea & US tensions, US Supreme Court recent decisions, Congressional Reform, School shootings/gun control, etc.). Students are expected to be courteous and respectful to perspectives different than their own and conduct themselves within the guidelines set forth in our debate procedures. Parents are encouraged to inquire about current class topics to stay informed. Should there be any legitimate concern with an assigned topic; the parent MUST contact the instructor directly to arrange an alternative topic/assignment as soon as possible. DO NOT send a message or note with your child, as it will NOT be accepted. Furthermore, over the course of the year, we may be watching several movies that are relevant to our content focus. These movies may be rated PG-13 and will be followed up with a learning activity (i.e.; Runaway Jury, The Hunger Games, The Wave, Historical documentaries, etc.) should there be any issue with giving parental consent for these movies, the parent MUST contact the instructor directly to arrange an alternate assignment as soon as possible. DO NOT send a message or note with your child, as it will NOT be accepted.

## F. Course Grades, Assignments, & Policies:

Grades will reflect an assessment of the mastery of the content, necessary skills, and based on your performance. A varied means of assessment may include but are not limited to:

\* Midterm & Final Exams account for 20% of a student's GPA in all academic classes and may possibly be projects and/or other

forms of assessment rather than traditional paper & pencil exams. In addition, their <u>final</u> EOC will count<u>30%</u> towards <u>overall course grade</u>. \*\*Extra credit assignments will <u>not</u> be given\*\*

#### Journals:

Students are required to have a composition notebook for <u>daily</u> journal entries which topics will be posted on the board at the beginning of class and a paragraph must be written on the topic within the first 5-7 minutes of class. These topics consist of PMA, goal setting & character education. Journals <u>MUST</u> remain in class and are graded weekly.\*DO <u>NOT</u> TAKE HOME or that weekly grade will result in an **F** grade\*
